**WHEREAS** (i) the said Mr/Mrs\*/ ..... is the owner/authorized user of the collective marks or mark or copyright and is indebted to the **THE DIRECTOR GENERAL - MAURITIUS REVENUE AUTHORITY** in the sum of Rs .....(Rupees .....)
